Methods of Payment

- Fees are payable in 2 months or 3 months instalments.
- Fees are payable over 10 months. Net 30 days from December 2025 to September 2026.
- Fees are payable via EFT or cash deposit into the account.

We do not accept cash nor use POS machines for school fees

Early Payment Discount

A 7% discount is granted for annual payments made on or before 10 January 2026.

Please note:

Early payment discount refers to school fees only and NOT to levies.

Family Discount

- 10% for 2nd child
- 15% for 3rd child
- 20% for 4th child

Please note:

Family discount refers to school fees only and NOT to levies.

Development Levy (Once Off Payment for New Enrolments)

- Pre School (Reception) P 5 000
- Primary School P 5 000
- High School P 5 000

Please note:

The School Development Levy is a compulsory contribution payable upon first entry into Rainbow Schools. It applies to all new students enrolling from Reception to Standard 7, and again when progressing to the High School from Form 1 to Form 6. Preschool Classes 3 and 4 are exempt from this levy for the duration of their primary education.

The funds collected are dedicated to specific development projects that enhance the school's infrastructure, improve learning environments, and ensure that our facilities continue to meet the evolving needs of our students—providing a richer and more effective educational experience.
